## OnCampus – Refer a Friend: Terms and Conditions

---

This offer is intended to benefit both the Referrer and the new Student.

### 1. The offer for the Referrer (enrolled students and alumni of OnCampus)

Enrolled students and alumni who successfully refer a friend to an OnCampus course will be entitled to receive a shopping voucher. This benefit will be confirmed once their friend has enrolled on and arrived in the Centre for their chosen course with OnCampus.

Enrolled students and alumni can refer multiple friends and will receive the benefit in the form of a shopping voucher for each friend that successfully enrolls on their OnCampus course.

The Refer a Friend initiative only applies to students who submit their application directly via an OnCampus Student Advisor. Students who apply via an education agent are not eligible for the Refer a Friend discount/voucher. The different values for each applicable shopping voucher are set out below:

Course Duration	Agent application or application from non-agent channel	Voucher value
Any 2 or 3 semesters courses	Non-agent / direct applications	£500
Any 1 semester courses	Non-agent / direct applications	£300

The official “Refer a Friend” form must be completed **prior** to submission of the referred student’s application. The form is available at: [Refer a Friend | OnCampus](#). All required fields must be completed, including the referrer’s full name, Study Centre, and Student ID (as shown on the original OnCampus offer letter, beginning with “OCXXXXXX”). Failure to provide complete and accurate information will result in the referral not being registered and the shopping voucher not being issued.

A current student or alumni who refers a friend under this scheme should not share any personal data of their referred friend to OnCampus and all referrals must be made via the referral link stated above, by only the referred student at the start of their application process.

OnCampus is responsible for processing any personal data that is shared with it directly by the referred individual. More information on how data is managed in accordance with Data Protection laws can be found here: [Privacy policy | Cambridge Education Group](#).

### 2. The offer for the referred student

In all cases where the referred student complies with these terms, the referred student will receive their discount of £1,000, either from their tuition fees value, if paying in full, or from their final instalment, if paying in accordance with an agreed payment plan.

### **3. Limits and Conditions to offer**

OnCampus will not be responsible or liable for any third parties acts or omissions or goods or services, once a shopping voucher has been issued.

Sponsored students (being those students sponsored by third parties and not self-funded) are not eligible to receive any discount on their tuition fees under this offer, but the Referrer can claim a shopping voucher.

Shopping vouchers will only be issued following confirmation that the referred student has successfully enrolled and remained enrolled beyond the official add/drop deadline. Enrolment verification will take place after the relevant intake cut-off date (typically early December for September intakes and early March for January intakes). Vouchers will be issued to eligible referrers only after this verification process is complete. The Referrer must then apply for the shopping voucher no later than two calendar months after the start of that course, otherwise the shopping voucher offer will expire.

Only vouchers will be issued and no monetary value/equivalence will be given. All vouchers will be issued in GB Pounds sterling, unless the referred student has enrolled on their chosen course with OnCampus at one of our Centres in Europe, in which case the currency will be euro.

OnCampus reserves the right to change or withdraw this offer at any point and without prior notification.
