UniHaven Child Safeguarding Statement

1. The purpose and scope of this policy statement

UniHaven helps international students to gain access to predominately Irish HEIs by recruiting them through its agent networks and online channels, teaching them its accredited foundation pathway programmes ("foundation programme" or "pathway programme"), and progressing those who successfully complete these programmes to HEI partners with whom it has written agreements. Our core values are:

- Student Care
- Quality
- Integrity
- Professionalism

We provide the following activities regarding current students and potential students.

- Admission, including pre-arrival communication.
- Registration.
- Teaching, Learning and Assessment.
- Accommodation.
- Social and University Activities
- Progression to HEI Partners.

The purpose of this policy statement is to protect children and young people who receive Unihaven services from harm. This policy applies to anyone working on behalf of UniHaven, including senior managers and the Board of Directors, paid staff, volunteers, sessional workers, agency staff and students.

2. Commitment to compliance with national legislation and policy

This policy has been drawn up on the basis of legislation, policy and guidance that seeks to protect children and young people in Ireland. A summary of the key legislation and guidance is available from the TUSLA website link: www.tusla.ie.

3. Declaration of Guiding Principles

We believe the following:

- 1. Our priority to ensure the welfare and safety of every child and young person who attends our service is paramount.
- 2. Our guiding principles and procedures to safeguard children and young people reflect national policy and legislation and we will review our guiding principles and child safeguarding procedures every two years.
- 3. All children and young people have an equal right to attend a service that respects them as individuals and encourages them to reach their potential, regardless of their background.

- 4. We are committed to upholding the rights of every child and young person who attends our service, including the rights to be kept safe and protected from harm, listened to, and heard.
- 5. Our guiding principles apply to everyone in our organisation.
- 6. Workers/volunteers must conduct themselves in a way that reflects the principles of our organisation.

4. Nature of service and principles to safeguard children from harm

We interact with students and their parents/guardians and agents who may represent them at admissions stages to ensure they are suitable to study with us and to provide advice as to how to prepare for study in Ireland, which often includes arranging their accommodation with our head office accommodation team. This includes, for those under 18, a referral to our guardian nominee provider who will support minors in all aspects 24/7 in Ireland. Working in partnership with relevant stakeholders, including young people, their parents, carers, and other agencies is essential in promoting young people's welfare. Once students have been registered, we enrol them once they arrive in Ireland after which we induct them about all College policies and procedures, including child protection and safeguarding and our student charter expected behaviours, and we teach and assess them while they study our programmes. While they study with us, we provide a range of social activities for them to enjoy, and we facilitate cultural and university visits. We do our best to ensure students achieve the required grades to progress to degree study at our HEI partners.

We recognise that all young people, regardless of age, disability, gender reassignment, race, religion or belief, sex, or sexual orientation have an equal right to protection from all types of harm or abuse. At all times, whether through communications online or in person, we commit to treating all students with dignity and respect in ways that support their positive health and wellbeing. If we have concerns, we raise them internally and/or with Tusla and/or An Garda Siochana in accordance with our Child Protection Policy to action these concerns in the best interest of the student.

5. Risk Assessment

We have carried out an assessment of any potential for harm to a child and young person while availing of our services including the area of safety when online communicating with our staff and each other online. Below is a list of the areas of risk identified and the list of procedures for managing these risks.
